The Board expressed their appreciation to the DEP representatives for attending the meeting. The Board also discussed submitting a Growing Greener Grant to evaluate and perhaps purchasing the Biddle Site.

- **E.** A draft list of stops for the WCD sponsored Bus Tour was provided to the TCWA board. The list included stops at the following locations: Fletcher's Equipment Site (erosion and sediment control, rain gardens and ponds); Borland Farm Road (acid mine drainage, slag pile and pipeline stabilization); Export (flood control project); Murrysville Community Park (rain gardens, stormwater detention and pervious concrete walkway); Bianca Rose Plan (stormwater retention and pond); Paul Thomas Fishing Hole (streambank stabilization, fish structure and discussion of "designated use); and IDC detention pond. F. The Growing Greener grant application for the support of the TCWA was discussed. Chelsea Walker provided a draft of the grant application for Board review. TCWA will provide a letter to the WCD for the grant application identifying the TCWA will provide matching monies to support the grant. A request for a laptop computer for the TCWA will be included in the grant application. A letter of support for this grant application was received from the Municipality of Murrysville.

F. Copies of the existing Borland Mine report out are to be sent to the Board members so they can better understand the situation and what has been done to date.

VI. New Business:

- **A.** A letter will be sent to the WCD by the TCWA to support the Growing Greener application for stabilization of sections of the Turtle Creek streambank along the Westmoreland Heritage Trail.
- **B.** Representatives (Jason McCabe and Andrew Maxwell) of Rivertowne Brewing were present at the meeting to request TCWA support for two potential projects, one involving stream restoration/flood control for the Turtle Creek Watershed stream adjacent to the Rivertowne Brewery and the second involving a green roof for the Rivertowne Brewery.
