- Approval of Minutes: A motion was made by Kevin Kaplan with a second by Chuck Duritsa to approve the meeting minutes from the November 28, 2018 meeting. Motion approved.
- Treasurer's Report and Invoices: A motion was made by Chuck Duritsa with a second by Kelly McLaughlin to approve the Treasurer's Report and the invoice for expenses submitted by Tom Keller. Motion approved.
  - A. Executive Director's Report: Tom provided the following updates. Tom is drafting, with the assistance of Susan Forney and Bill Mihalco, the 2019 membership letters. The letters should be issued within the next week. Tom reported that he purchased \$200 of stamps and \$24.24 in envelopes funded through the WPC grant. A discussion of distributing the remaining sewer tags and pollinator seeds was held and will be discussed again at a future meeting. Tom noted that we have only spent approximately \$270 of the \$1,000 Foundation for PA Watershed grant. We need to spend the remaining money on social media events. Tom will discuss this further with Jessica and Alyssa in the near future. Tom reported that TCWA did not receive a Community Foundation of Murrysville, Export and Delmont grant for TCWA bookmarks. Tom also reported that he will be representing the TCWA at the upcoming Watershed Group Social sponsored by the Allegheny Watershed Alliance on February 1, 2019. The invitation to the event was shared with Board.

- **C.** Jim Brucker reported that he received a letter from the Sewickley Watershed Association giving TCWA a free membership to their association. TCWA will give Sewickley Watershed Association a membership to TCWA. Kevin Kaplan reported that no significant emails were received since the last meeting
- C. Ducky Race: Alyssa has met with Irwin officials but no other information was available.

"Reimagining Our Westmoreland" is the 2018 Comprehensive Plan for Westmoreland County developed by the Westmoreland County Department of Planning and Development. The plan discusses support for mine drainage treatment of Tinker's Run and Brush Creek which the TCWA refers to as the Irwin Discharge. A motion was made by Kelly McLaughlin with a second by Chuck Duritsa to issue a resolution supporting "Reimagining Our Westmoreland". Motion approved. President Brucker signed the resolution and Tom Keller will mail the signed resolution to Westmoreland County.
- **D.** Bill Mihalco reminded all Directors and Associate Directors of the need to review the Conflict of Interest Policy and to sign the Conflict of Interest Statement.

- Approval of Minutes: A motion was made by Kevin Kaplan with a second by Kelly McLaughlin to approve the meeting minutes from the January 22, 2019 meeting. Motion approved.
- Treasurer's Report and Invoices: A motion was made by Kevin Kaplan with a second by Kelly
  McLaughlin to approve the Treasurer's Report and the invoice for expenses submitted by Tom
  Keller. Motion approved.
- Executive Director's Report: Tom provided the following updates. Tom reported we have approximately \$740 left on the Foundation for Pennsylvania Watersheds grant. The grant was issued to fund social media means to publicize the TCWA and expand membership. Tom lead a discussion on ways the remaining grant money could be spent. A suggestion was made to consider hiring a social media company which Alyssa agreed to investigate. Tom agreed to contact the FPW to discuss the current status of the grant and to request any extensions if needed. Tom noted that he is working on the Sales Tax Exemption and will submit additional information to the State as requested. Tom passed out applications and asked the Board members to distribute the applications. Tom also noted that we have seed remaining from last year that needs to be distributed. One idea was to give the seed to local libraries as part of a presentation on the TCWA. Several attendees suggested that the Boy or Girls Scouts might be good organizations to package the seeds or to use the seeds. Alyssa agreed to check on what, if any, monies remain in the grant for the seeds.

- **A.** Irwin Discharge: Jason McCabe report by text that he has the proposal for the Hydrologic Unit Plan prepared and is waiting for an announcement when the next round of Growing Greener grant applications can be submitted. In the interim, Jason is pursuing support letters from local legislators and municipalities.
- **B.** Grant Writing Committee: Alyssa Harden reported that she submitted and obtained another Dominion Minigrant for a Tabletop rainfall simulator. The grant was for \$980 and will be provided at the annual luncheon for the grants to be held on March 29, 2019 at the Blairsville Country Club.
- **C.** Kevin Kaplan reported on the emails were received since the last meeting which will all be addressed.
- **D.** Ducky Race: Alyssa has met with Irwin officials and a date for the Ducky Race has been set for June 22, 2019 at the Irwin Park. The event will run from 11 am until 2 pm. Irwin Boro will assist with the planning, advertising and with conducting the event.
- **D.** Newsletter: Efforts will begin to issue a newsletter in the April/May timeframe.

- **E.** Spring Activity: Tom was requested to contact Keep Pennsylvania Beautiful to discuss TCWA working with them on a cleanup project.
- **F.** Status of the second kiosk: Jamie Storey is working to have the second kiosk built and erected along the Westmoreland Heritage Trail. The location has been moved from the parking lot at Saunders Station to a location along the trial.
- **G.** Bill Mihalco reminded at Directors and Associate Directors to sign their Conflict of Interest Statements for 2019.
- **H.** During the January meeting, Bill Mihalco presented revisions to the TCWA bylaws to define the positions of Associate Director and Director Emeritus by adding Section V.11 and Section V.12 and modifying Section V.6 of the bylaws. A minor revision to Section V.11 was suggested which entailed adding the word "and/or events" after meetings in the third sentence of the Section. A motion was made by Kelly with a second by Kevin Kaplan to approve the changes to the bylaws as written. Motion approved.

- **A.** Board members were requested to review a list of accomplishments for 2018 provided with the agenda and submit any comments, revisions or additions to Bill Mihalco so the list can be finalized at the next meeting.
- **B.** The GoDaddy subscription for the website expires at the end of April. Alyssa Harden recommended that TCWA consider using another more user friendly platform called WordPress. After some discussion, Kevin Kaplan made a motion to investigate WordPress and if it is simpler and easier to use along with being cost effective to switch from GoDaddy to WordPress. Bill Mlhalco seconded the motion. Motion approved.
- **C.** Bill Mihalco noted that Turtle Creek is on the Fish Commission stocking list for 2019. Bill reported that he discussed the condition of the stream with a fishery biologist out of Somerset. The Fish Commission has plans to sample Turtle Creek the weeks of March 11, March 18 and April 1. Based on the results of these sampling efforts the Fish Commission will make a final decision on stocking Turtle Creek. Bill will contact the Fish Commission and try and determine the dates for the sampling efforts so that TCWA members can participate if available.
- **D.** Bill Mihalco reported that the Westmoreland Conservancy website has a link to TCWA website but the link is not active. It was suggested that we provide the Conservancy with our current website address so they can update the link. Kevin Kaplan agreed to provide the information to the Conservancy. It was also noted that the Conservancy just added about 83 acres adjacent on one of their preserves that includes Lyons Run a tributary to Turtle Creek. Jessica Kane received a request to have someone from the TCWA participate in a Friends of Murrysville Parks event in the summer at Duff Park. Jessica was requested to contact the Friends of Murrysville Parks to identify that TCWA would participate.
- **E.** The TCWA 990 form is due to be submitted to the IRS soon. Bill Mihalco agreed to follow up with Jim Brucker to discuss submission of the form.
- **F.** The Board discussed that the Reimagining Our Westmoreland report issued by Westmoreland County had an action to address the Irwin Discharge in the report. The Board will discuss TCWA participation in efforts to complete the report action at future meetings.
